- 一、義守大學國際商務學系(以下簡稱本系)依「義守大學組織規程」第三十條規定，特訂定「義守大學國際商務學系系主任遴選要點」(以下簡稱本要點)。
- 二、本系置系主任一人，綜理系務，一任以三年為原則，連選得連任二次。
- 三、系主任之產生方式，應於當任系主任任期屆滿前三個月，由系務會議就專任副教授（含副教授級專業技術人員）以上教師遴選二至三人，報請院長同意後，送請校長擇一聘兼之。
- 四、系主任於任期屆滿前因故出缺者，由院長就本系專任副教授級以上教師擇聘一人，報經校長同意，暫代所遺職務，並應於三個月內依前點規定，遴選新任系主任。
- 五、本要點經系務會議審議通過，送交管理學院核備，陳請校長備查後自公告日實施。

Guidelines on the Selection of Chair of Department of International Business at I-Shou University

Amendments to the Guidelines promulgated with the
consent from the President dated on March 28, 2018

- I. The Guidelines on the Selection of Chair of Department of International Business at I-Shou University (hereinafter referred to as "the Guidelines") are developed by the Department of International Business (hereinafter referred to as "the Department") pursuant to Article 30 of the Charter of I-Shou University.
- II. The Department shall have one chair to take overall charge of departmental affairs. The Chair shall serve a three-year term and may be re-elected twice.
- III. The Departmental Affairs Council shall recommend 2 to 3 full-time faculty members or professional technicians at or above the level of Associate Professor to the Dean of the College of Management for approval three months prior to the expiration of the current term. One of the candidates will then be selected and appointed by the President.
- IV. If the Chair of the Department resigns before the expiration of the term, the Dean of the College of Management shall appoint a full-time faculty member at or above the level of Associate Professor to act as acting chair with prior consent from the President. A new chair shall be elected within three months in accordance with the Guidelines.
- V. The Guidelines become effective on the third day of promulgation after being adopted by the Departmental Affairs Council, approved by the College of Management, and ratified by the President.

Note: In the event of any disputes or misunderstanding as to the interpretation of the language or terms of the Guidelines, the Chinese language version shall prevail.
